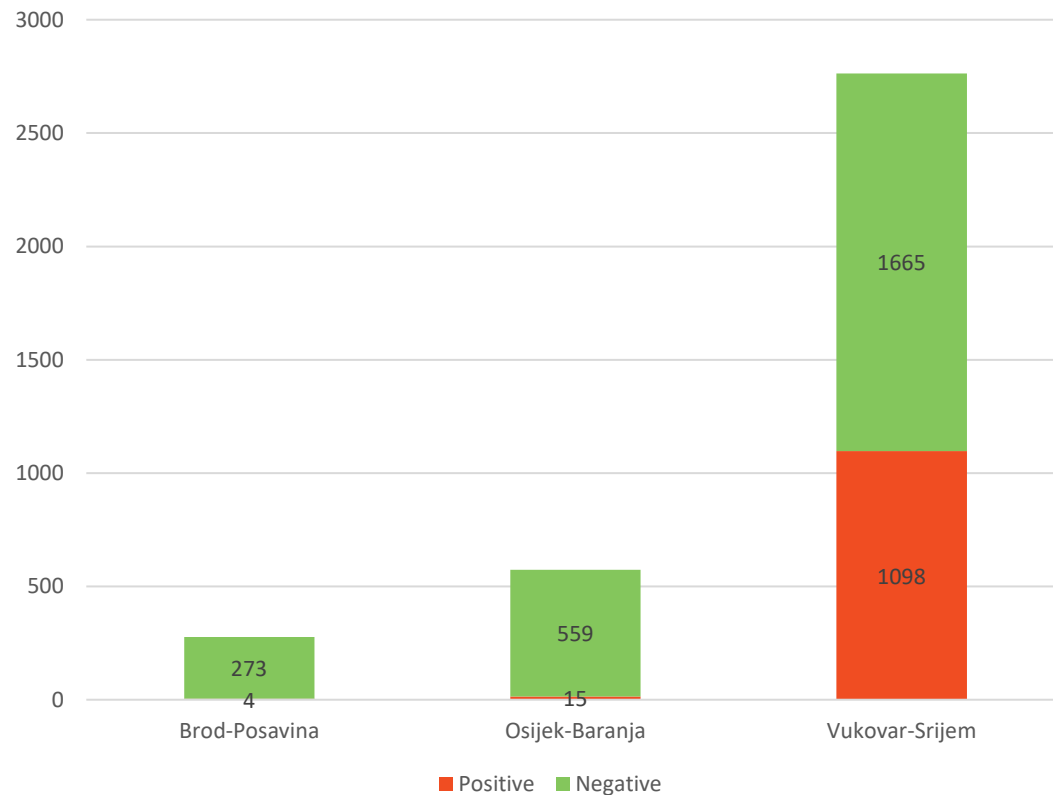
Current ASF situation in kept pigs

- **No outbreaks in past 15 days**
- Last outbreak confirmed on 1 Dec. 2023 in protection zone (VS County)
- No open suspicion

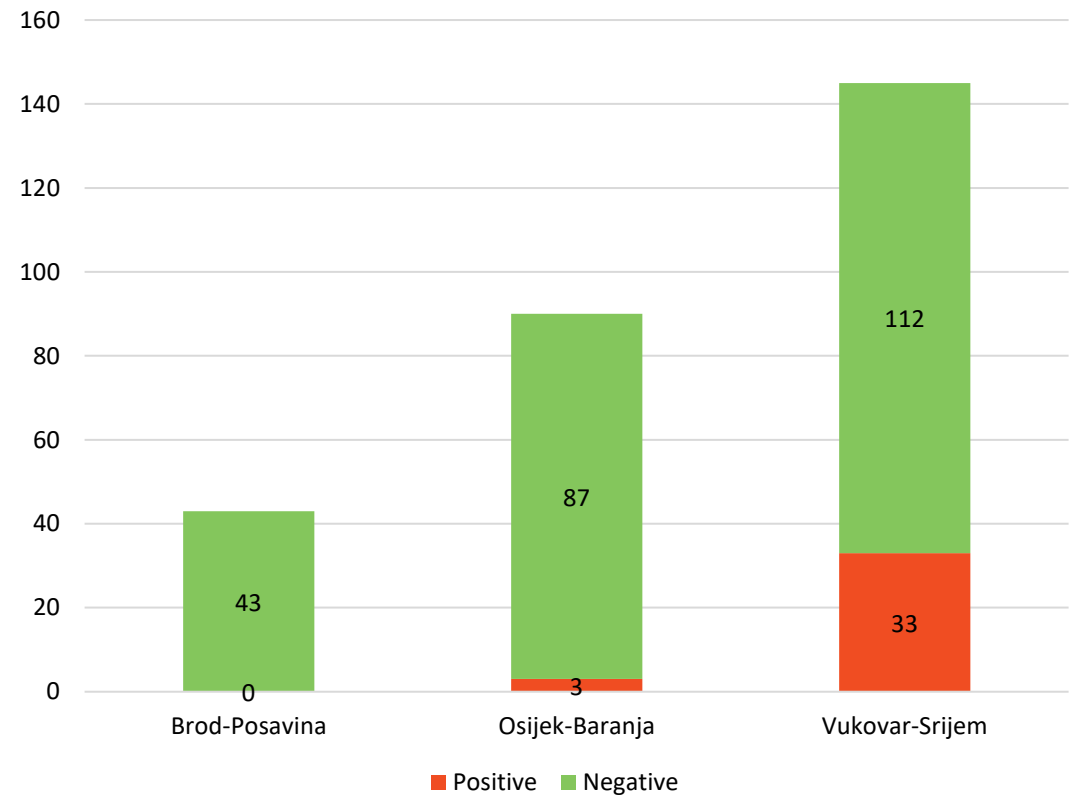


ASF passive surveillance in kept pigs July - Nov

No. of tested establishments

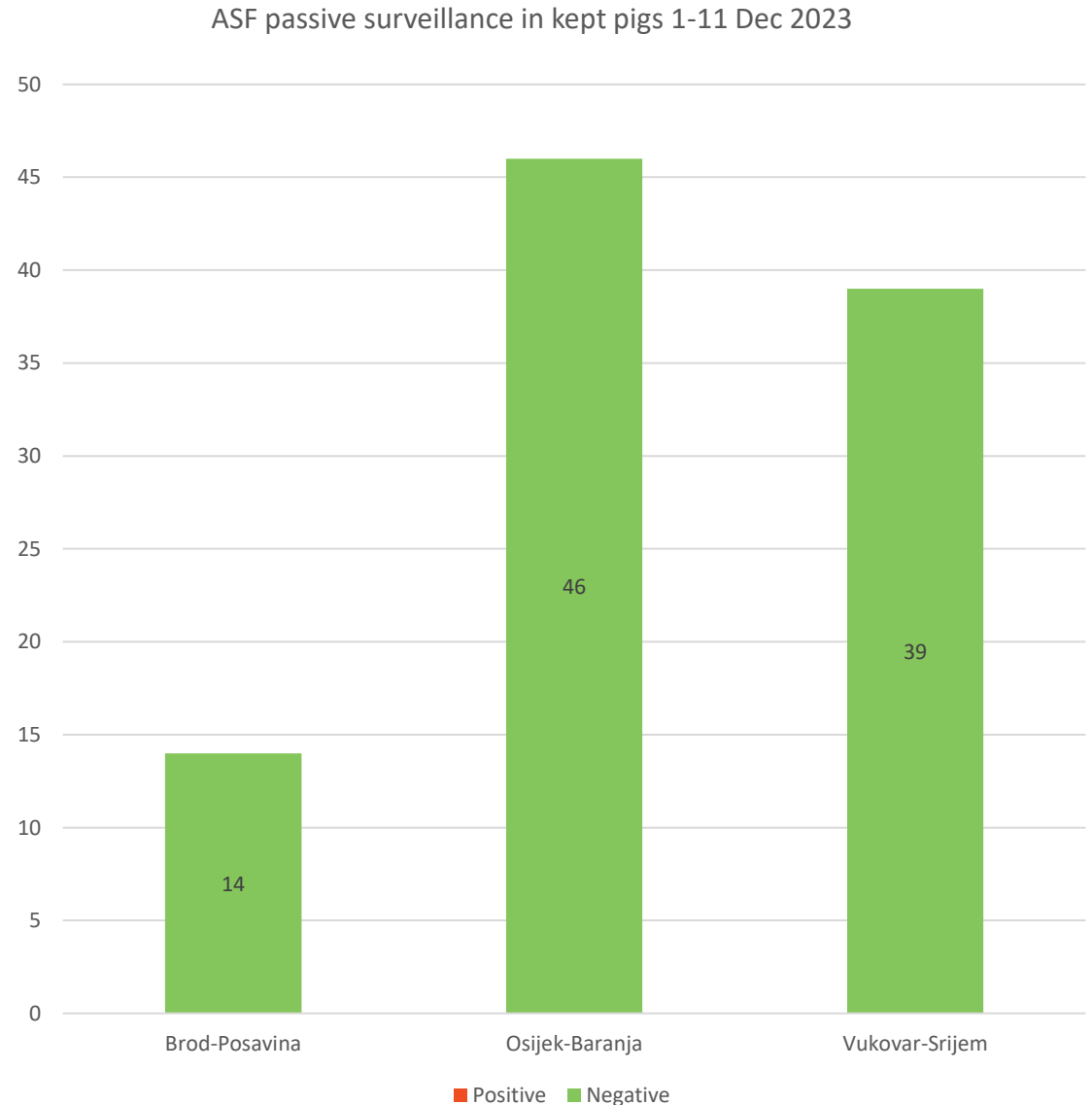


ASF passive surveillance in kept pigs **November** 2023

ASF passive surveillance in kept pigs *1 – 11 December*

- *In restricted zones* mandatory testing of all dead pigs (except suckling piglets)
 - ASF ruled out on 99 farms in RZ
- *Outside RZ* testing of each dead pig on establishments with up to 100 animals, and on establishments above 100, two dead pigs every week from each epidemiological unit
 - ASF ruled out on 186 farms in 19 free counties



Ongoing and completed control measures

- Reg. 2016/429, DR 2020/687, IR 2023/594, National Animal Health Law (OG 152/22, 154/22)
- **Order on control measures to combat ASF in Croatia (OG 147/23)**
 - New measures in force from Dec 13
- **ASF Action plan** with short, medium and long term activities **updated**

WB surveillance RZ and infected zone 10 positive cases in period July- 12 Dec Last case on 23 Nov.



8 positive WB in passive surveillance, 2 positive in active surveillance

Current restricted zones

Part I and II – SM, KA and LS Counties

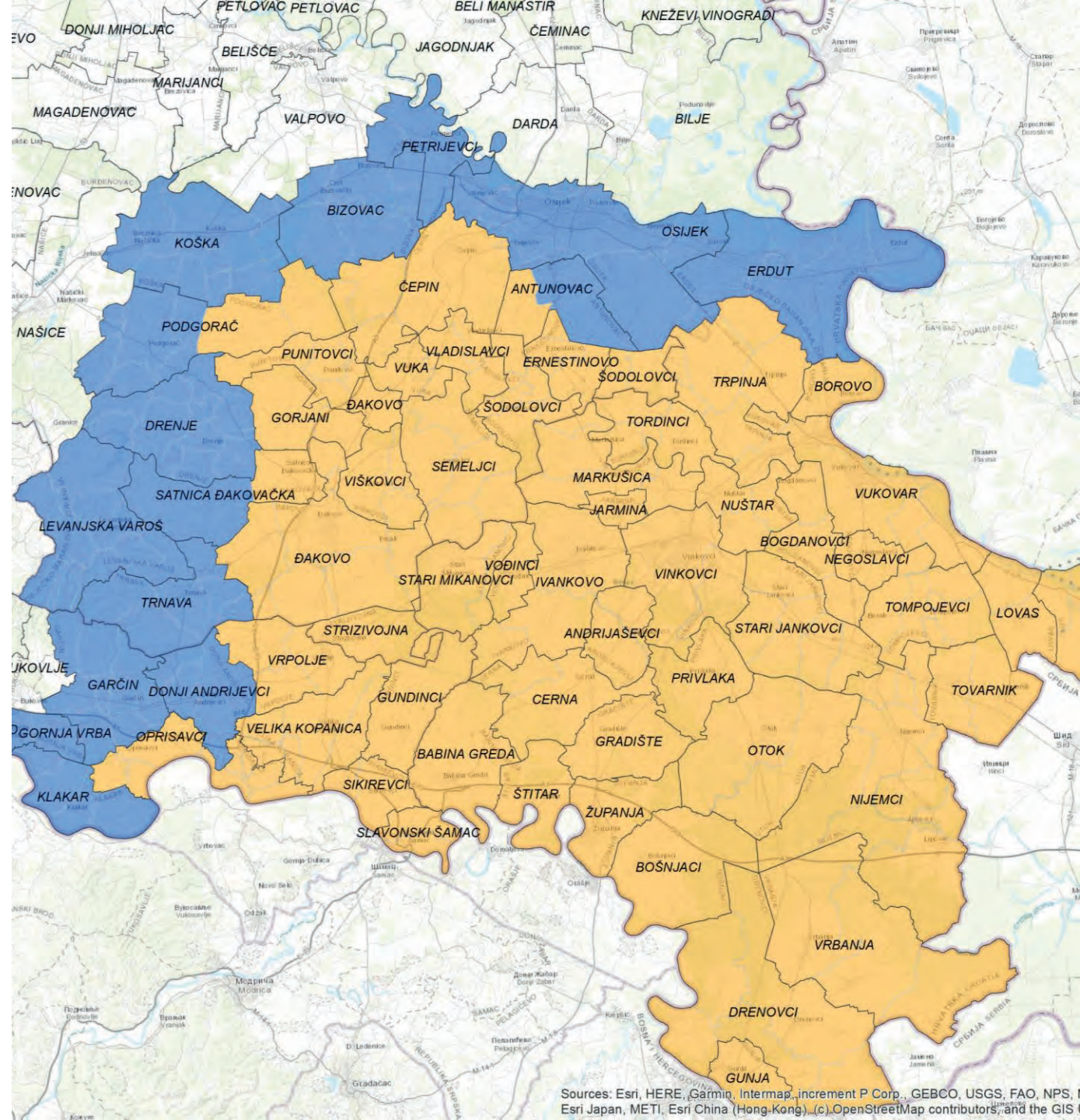
Infected zone – Zadar County

Protection and surveillance zone – VS, OB
and BP Counties



Proposal for the new zoning Acc. IR 2023/594

- Current surveillance and protection zone – Part III
- Additional Part I in BP and OB County



Pros for the regionalisation

- Stable epidemiological situation, no new outbreaks
- Majority of ASF outbreaks concentrated in the area Vukovar-Srijem County
- Very limited spread to neighbouring area of Brod-Posavina (4) and Osijek-Baranja (15) County
- Enlargement of zone – previously surveillance zone included in Part III and additional zone added as Part I covering free territory
- Noncompliant farms not allowed to keep pigs
- Increased controls and visits in force
- Increased biosecurity
