



Report of Sheep Pox Outbreaks in Greece, 12.01.2018


The Greek Veterinary Authorities would hereby like to inform the European Commission and Member States regarding the recent outbreaks of Sheep Pox in Greece.

Since our previous report, on 05 December 2017, five (5) more outbreaks have been confirmed, one (1) in 2017 (08.12.2017) and four (4) in 2018, in all cases, Capripovivius genome was detected with real time PCR in skin lessons and/or blood samples from affected sheep.

SGP in Greece-Lesvos Island–October 2023 first case (2023/1)



- Mixed sheep farm
- Date of confirmation: 24.10.2023

- 55 sheep (52 ewes,2 rams,1 lamb)
- Location: Municipal Department of Sigri,
- Municipality of West Lesvos, Lesvos Regional Unit, Region of North Aegean




- ✓ From 16.11 to 21.11.2023 clinical surveillance has been performed in all farms (Protection Zone-Surveillance Zone) with no clinical findings.
- ✓ From 22.11. to 12.12.2023 clinical surveillance has been performed in 8 farms closest to the affected one in the context of Four (4) Exotic-Transboundary Diseases (TADs) Program with no clinical findings.




- ✓ From 13.12.2023 to 17.01.2024 clinical surveillance has been performed in
- √ 5 farms with 1110 sheep located inside subunit I
- √ 5 farms with 1790 sheep located inside subunit II
- ✓ 5 farms with 1110 sheep located inside subunit III in the context of Four (4) Exotic-Transboundary Diseases (TADs) Program with no clinical findings.

All measures foreseen in Reg. (EU) 2020/687 and the National Contingency Plan No 1747 /386028/2023 are implemented:


- ✓ **Zoning:** Protection Zone with a **radius of 10 Km** and Surveillance Zone with a **radius of 20 Km** around outbreaks
- ✓ Total Stamping out of all animals in the affected flocks
- ✓ Sanitary burial of carcasses
- ✓ Animal Movement Control within the zones
- ✓ Prohibition of the dispatch outside the RU of Fthiotida, of live ovine and caprine animals as well as semen, ova, embryos, ovine and caprine animal byproducts, hides and skins.
- ✓ Cleaning and disinfection of the farm
- ✓ Enforcement of biosecurity measures regarding farms, slaughterhouses and commercial activities.
- ✓ Surveillance of all herds within the Surveillance and the Protection Zone

SGP in Greece 2023-2024

COMMISSION IMPLEMENTING DECISION (EU) 2023/2725

of 29 November 2023

concerning certain interim emergency measures relating to sheep pox and goat pox in certain Member States



- ✓ Movements of sheep and goats from the further restricted zone authorised by the competent authority
- ✓ Directly to a slaughterhouse located within the territory of Greece for immediate slaughter.
- ✓ The means of transport comply with the requirements for the means of transport laid down in Article 24(1) of Delegated Regulation (EU) 2020/687
- ✓ Only include sheep and goats of the same health status kept in the same establishment
- ✓ Be sealed by the competent authority at the establishment of origin after the loading
- ✓ Clinical inspection by the competent authority 24 hours or less before the date of transport.







SGP in Greece Epidemiological conclusions so far...

- ✓Illegal movements?
- ✓ Common crossing to pastures (link between 2023/4,2023/5 and 2024/2)



The EURL for Capripox viruses received samples from the NRL (both outbreaks 2023/1 and 2023/2), for phylogenetic analyses, in order to further assist the epidemiological investigation. The outcome of the tests is still pending.

Measures according Regulation 687/2020 are in place

Indicatively we mention:

- Vehicles transporting milk exclusively used in the protection and surveillance zone
- Cleaning and disinfection of all vehicles transporting milk before the entry and after the exit of each holding
- Each holding keeps a register of the movements of the vehicles coming in
- ➤ Milk to be pasteurized at 72° C or of equivalent result method
- Controls that need to be carried out in all holdings in the protection and surveillance zone (census, clinical examination etc)
- Controls on movements of animals
- Controls of movements of ABP
- Controls of movements for feeding stuff etc
