



*WORKING GROUP ON CONSUMER FOOD WASTE PREVENTION*  
*SUB-GROUP TO THE EU PLATFORM ON FOOD LOSSES AND FOOD WASTE*  
TERMS OF REFERENCE

## 1. BACKGROUND

As provided for in the terms of reference of the EU Platform on Food Losses and Food Waste (FLW)<sup>1</sup> and its rules of procedure, the Commission's Directorate-General for Health and Food Safety ('DG SANTE') may set up sub-groups for the purpose of examining specific questions on the basis of terms of reference defined by DG SANTE in consultation with Platform members. Feedback<sup>2</sup> from Platform members collected at the end of its first mandate highlighted the topic of consumer food waste as an important area where further work should be carried out at EU level, in order to change consumer behavior and social norms related to food waste generation. Therefore, DG SANTE took the initiative to establish a dedicated working group on consumer food waste prevention as a sub-group to the EU Platform on Food Losses and Food Waste

The sub-group will provide a forum to exchange information on interventions carried out to modify consumer behavior concerning food waste generation and/or raise consumer awareness about the issue and results achieved. The sub-group will be closely involved in the on-going EU pilot project, financed by the European Parliament, and carried out by DG SANTE in collaboration with the Joint Research Centre and the European Consumer Food Waste Forum<sup>3</sup> which aims to gather data and identify a variety of evidence-based, practical solutions to reduce food waste at the consumer level, including household and food services.

The sub-group is expected to meet twice a year (in addition to the Platform's plenary meetings) and its working language for meetings shall be English. The sub-group shall regularly report on its activities to the Platform.

For any aspect not explicitly mentioned in these terms of reference, the sub-group shall operate in compliance with the terms of reference and rules of procedure of the EU

Platform on Food Losses and Food Waste and the Commission's horizontal rules on expert groups ('the horizontal rules')<sup>4</sup>.

## 2. OBJECTIVES

The sub-group will operate with a view to identifying and implementing effective, evidence-based interventions to reduce consumer food waste.

In particular, the group shall aim to:

- 1) to identify priority areas for action in the design and implementation of effective interventions to reduce consumer food waste;
- 2) to ensure effective exchange of best practices, information and learnings related to consumer food waste prevention activities and their related impacts.

## 3. TASKS

The sub-group's specific tasks shall be:

- (a) to support the Commission in identifying and prioritising EU actions to promote consumer behavioural change and raise awareness concerning food waste generation;
- (b) to support members in identifying and implementing appropriate actions to reduce consumer food waste at national, regional and local levels, in particular interventions to change social norms that can achieve long-term impacts;
- (c) to contribute to the collection and analysis of information on consumer-targeted interventions. In this regard, the sub-group will work in close cooperation with the European Consumer Food Waste Forum, which delivered a compendium of evidence-based practical solutions and tools in July 2023<sup>5</sup>;
- (d) to monitor implementation of the recommendations for action<sup>6</sup> of the EU Platform on Food Losses and Food Waste as regards consumers;
- (e) to exchange information on the latest developments in consumer food waste prevention, experience, evidence-based good practices and lessons learned, focusing on Member States' contexts and needs in order to drive further action at scale at national level. Such information may also be shared through the [EU Food Loss and Waste Prevention Hub](#).
- (f) to contribute to awareness raising about the issue of consumer food waste and related EU-level actions (including work of the EU Platform on FLW) through targeted communications<sup>7</sup>, with common messages that are adaptable to national contexts and

deliverables accessible to a wider audience, including on the occasion of the International Day of Awareness of Food Loss and Waste (IDAFLW).

#### 4. MEMBERSHIP

1. Members shall be Member States' authorities, other public entities, and organisations. All members shall be selected among members of the EU Platform on FLW.
2. Member States' authorities, other public entities and organisations shall nominate their representatives and shall be responsible for ensuring that their representatives provide a high level of expertise. DG SANTE may refuse the nomination by an organisation of a representative if it considers this nomination inappropriate in the light of the requirements specified in the call for applications. In such case, the organisation concerned shall be asked to appoint another representative.
3. Member organisations who are no longer capable of contributing effectively to the sub-group's deliberations, who, in the opinion of DG SANTE, do not comply with the conditions set out in Article 339 of the Treaty on the Functioning of the European Union or who resign, shall no longer be invited to participate in any meetings of the sub-group and may be replaced for the remainder of their term of office.

#### 5. OBSERVERS

1. Individuals, organisations or public entities other than Member States' authorities may be granted an observer status, in compliance with the horizontal rules, by direct invitation.
2. Organisations and public entities appointed as observers shall nominate their representatives.
3. Observers and observers' representatives may be permitted by the Chair to take part in the discussions of the sub-group, and provide expertise. However, they shall not have voting rights and shall not participate in the formulation of recommendations or advice of the sub-group.

#### 6. CO-CHAIRS OF MEETINGS

In line with the Platform's terms of reference, '*sub-group meetings may be co-chaired by DG SANTE and Platform members, as appointed by DG SANTE based on their expertise and expressed interest to coordinate work related to their field of expertise.*' Co-chairs appointed from among the Platform members may request to hold meetings of their respective sub-groups, propose agenda items and topics for discussion. Co-chairing will take place on a rotational basis, for those members who have expressed an interest in acting as co-chair in their application form. Expressions of interest in co-chairing may be updated during the course of the Platform's mandate.

The Commission will update the **co-chairing calendar** based on the interests expressed by members.
