

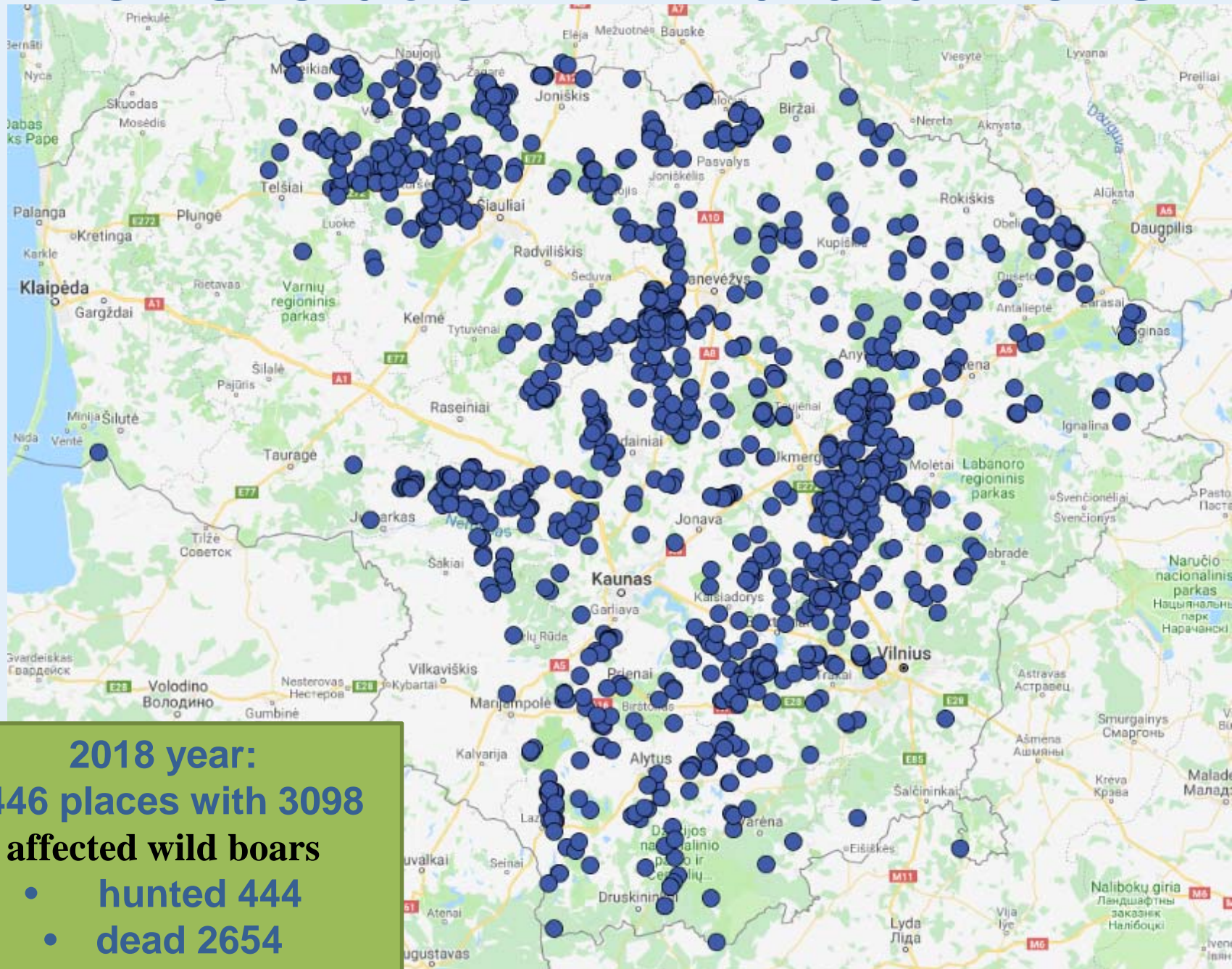

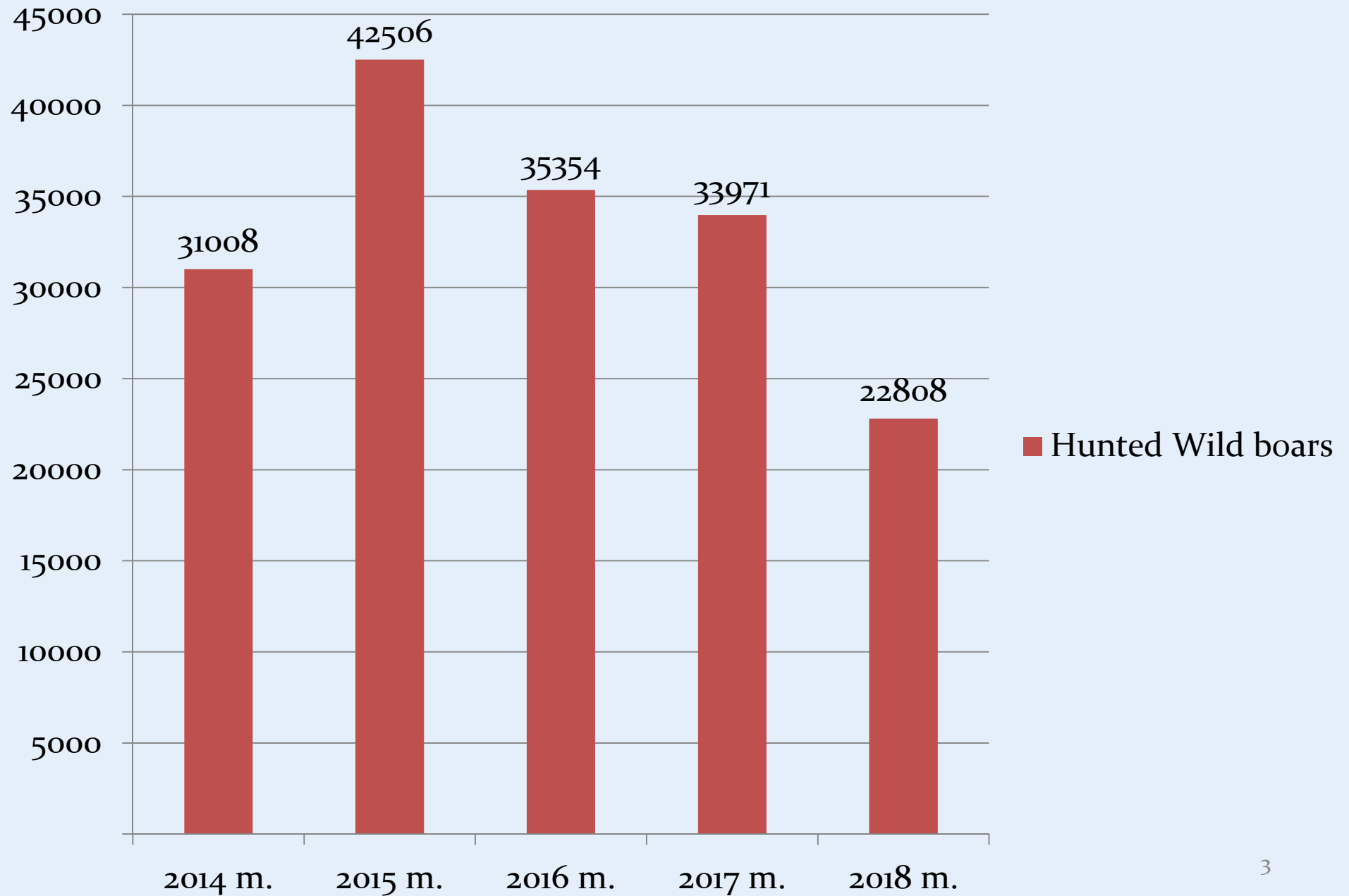
ASF evolution in wild boar 2018

affected wild boars

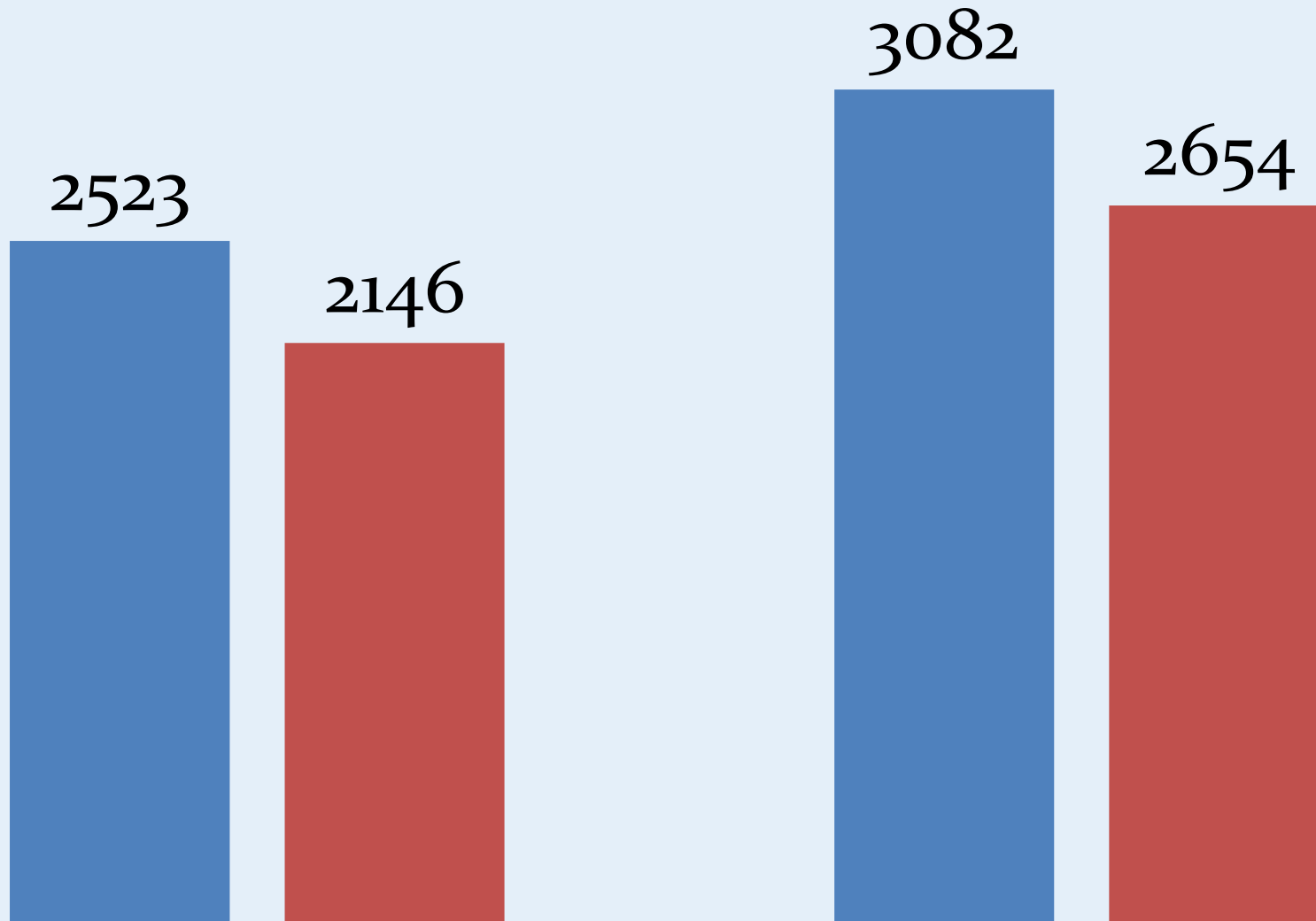

Found dead and positive for ASF

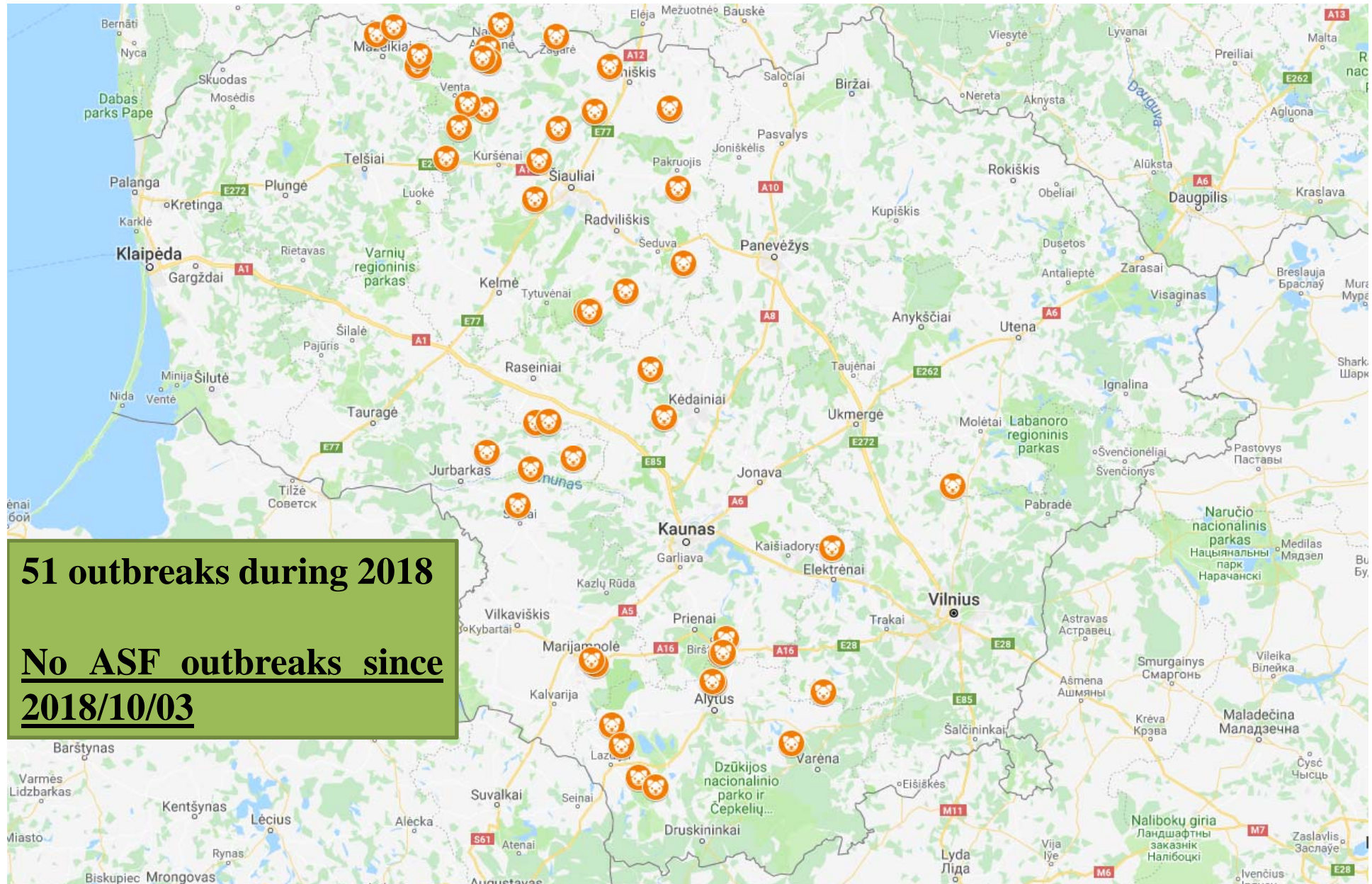
■ Found dead ■ Positive

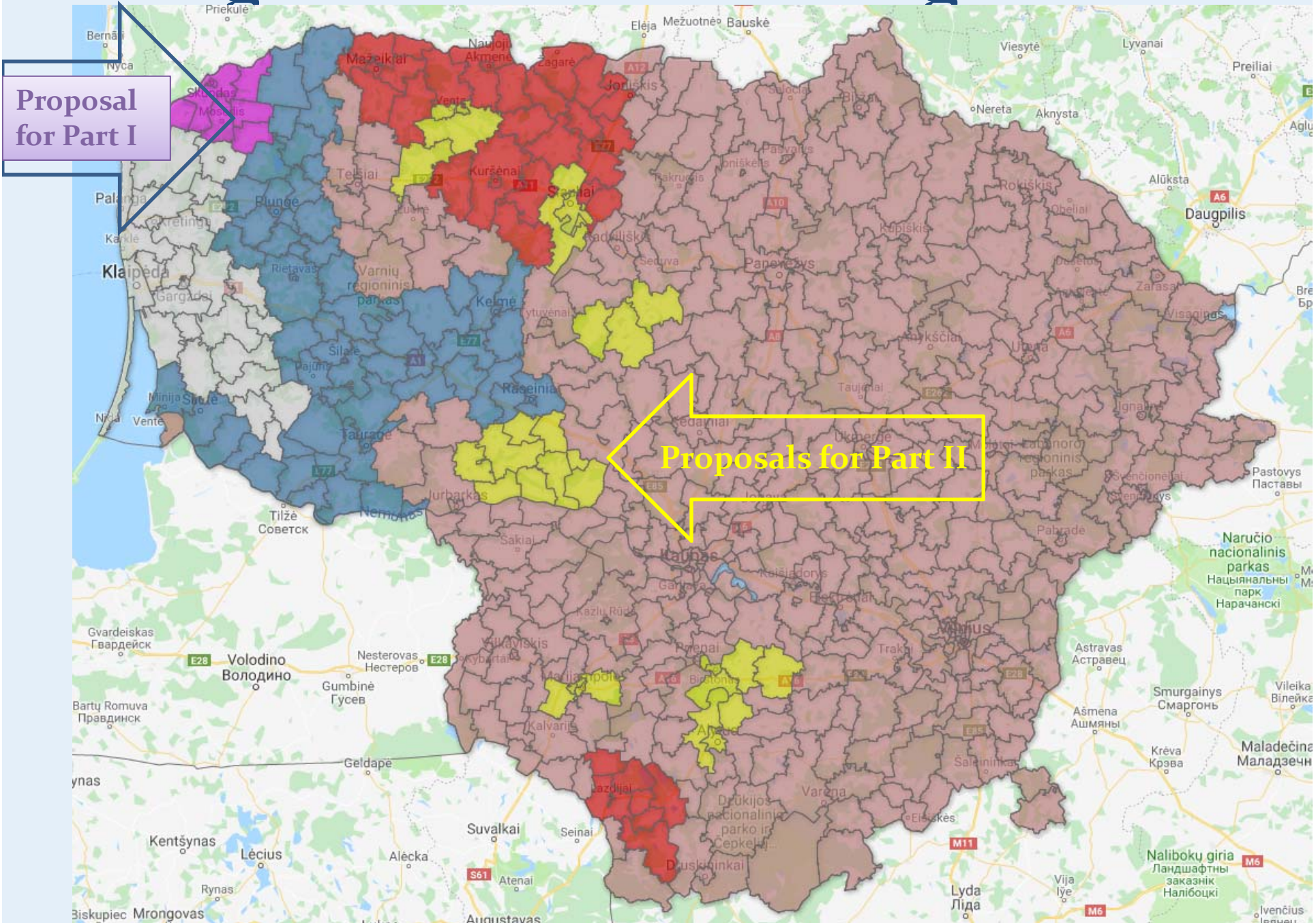
ASF in domestic pigs in 2018

Lifting Part III and reverting to Part II



Lifting Part III regionalisation and reverting to Part II are to be based on the following:

“Measures were applied corresponding to the criteria set up in the Working Document SANTE/7112/2015/Rev.3 point 1 b) “in case of total depopulation of all non-commercial farms with low biosecurity conditions, the period without any outbreaks can be reduced to 3 months” and in October – December 2018 official inspections have been performed in all pig farms and the farms which do not comply with the national biosecurity requirements were forced to slaughter pigs for own consumption, samples were taken and after negative result to ASF the meat was allowed to be consumed for personal consumption only”

- ❖ No outbreaks have been recorded in domestic pig farms last 3 months;
- ❖ Official inspections have been performed in the **commercial farms** and inspections have been performed individually in the **non-commercial farms** and it was concluded that the farms complied with the national biosecurity requirements;
- ❖ Based on the Order of CVO, all farms left will be re-checked for biosecurity requirement compliance until mid of May 2019, to be sure, that they comply with national biosecurity requirements until the “hottest ASF seasonal pick
