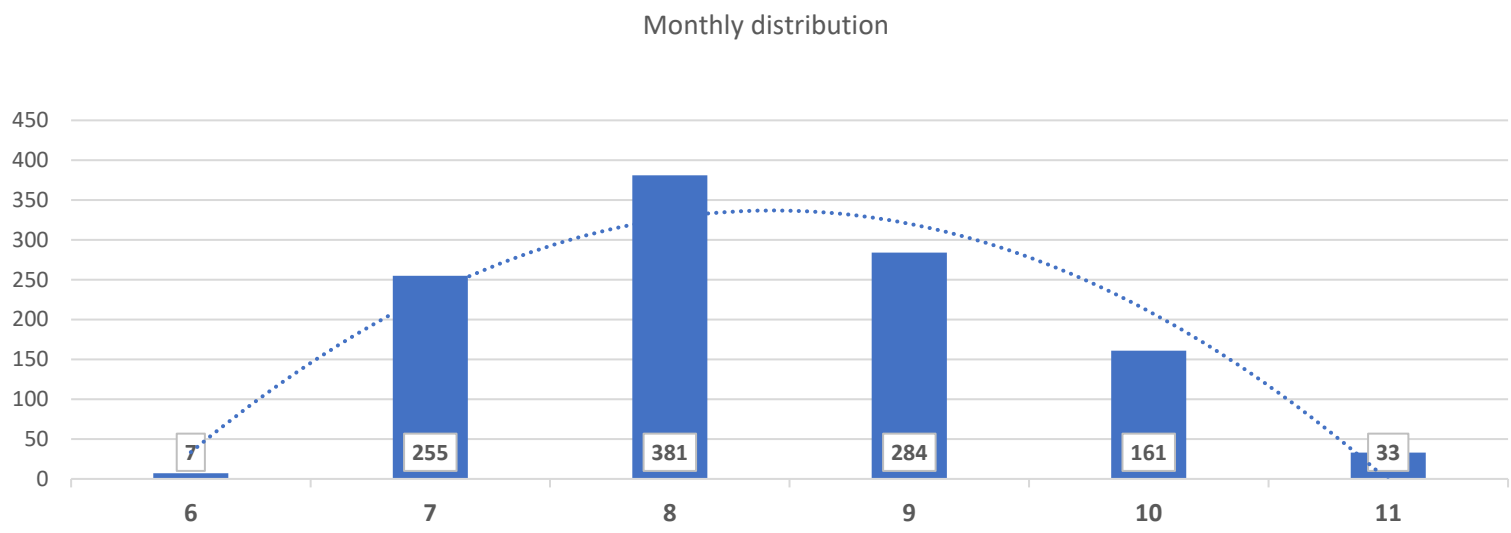
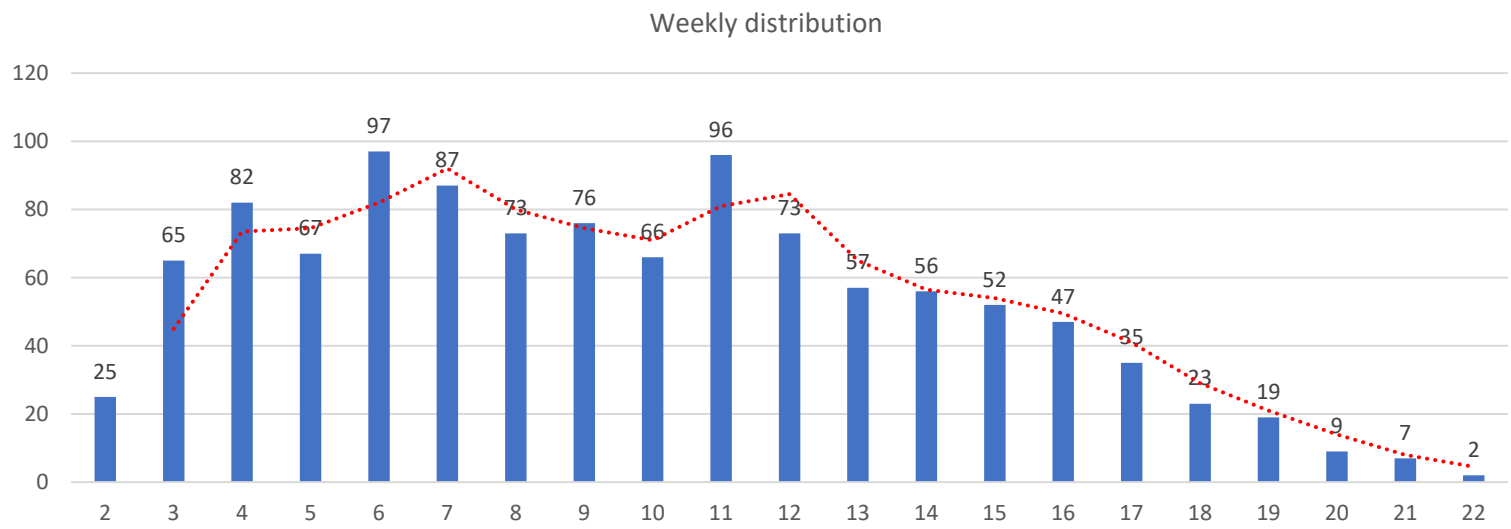

17 Oct – 22 November 2023

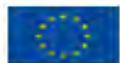


Significant decrease of number of outbreaks

COMMISSION IMPLEMENTING REGULATION (EU) 2023/2469

of 31 October 2023

amending Annexes I and II to Implementing Regulation (EU) 2023/594 laying down special control measures for African swine fever

Part of territory of Osijek-Baranja and Brod-Posavina County and whole Vukovar-Srijem County declared as restricted zone (protection and surveillance) according to DR (EU) 2020/687

Ongoing and completed control measures

LEGISLATION and other acts

- Reg. 2016/429, DR 2020/687, IR 2023/594, National Animal Health Law (OG 152/22, 154/22)
- Order on control measures to combat ASF in Croatia (OG 117/23, 130/23)
- Action plan for activities in restricted zones
- Guideline for clinical examination and sampling in restricted zones

- Census completed in restricted zones
- Deadline for emptying of non compliant establishments - November 30
- After the deadline pigs can be kept only on establishments fully compliant with biosecurity measures

- 28.200 pigs have been culled due to ASF suspicion or confirmation
- 7.153 pigs from 506 non compliant establishments were culled according to the Action plan
- 71.204 pigs were slaughtered and subjected to processing according to the Annex VII DR 2020/687 (data until Nov 13)

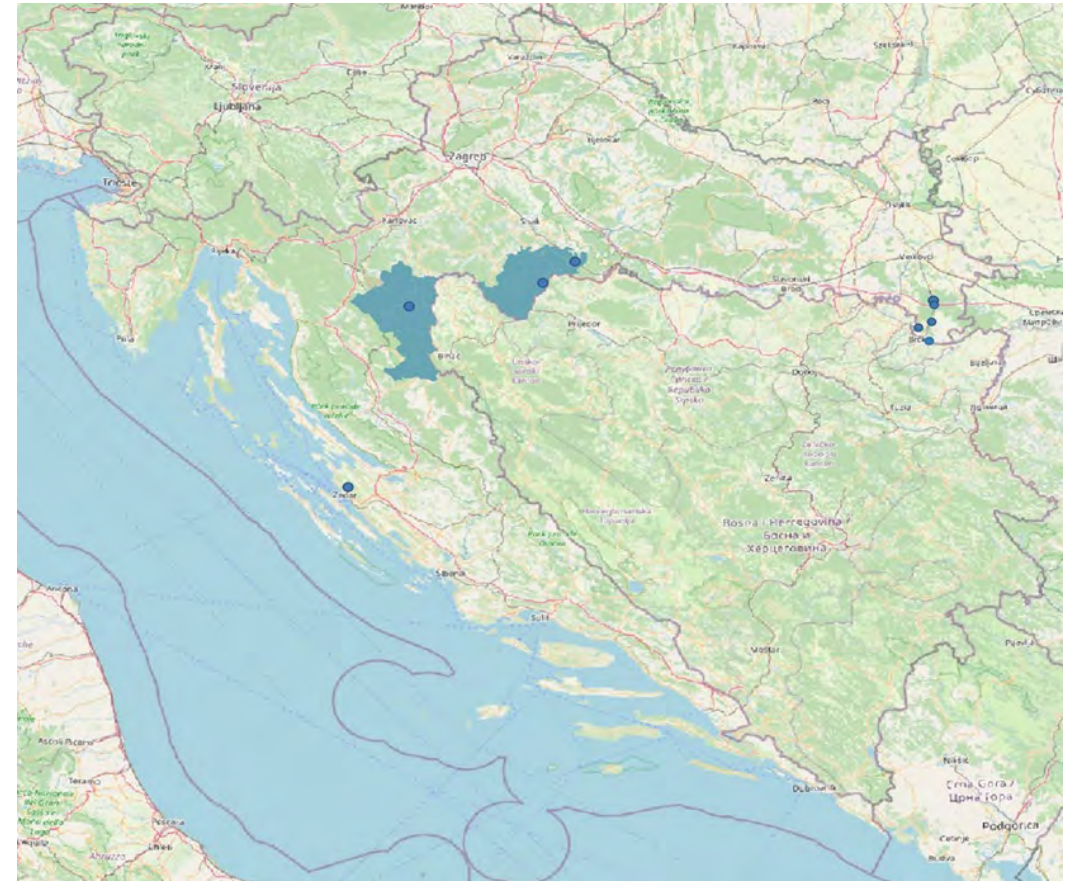

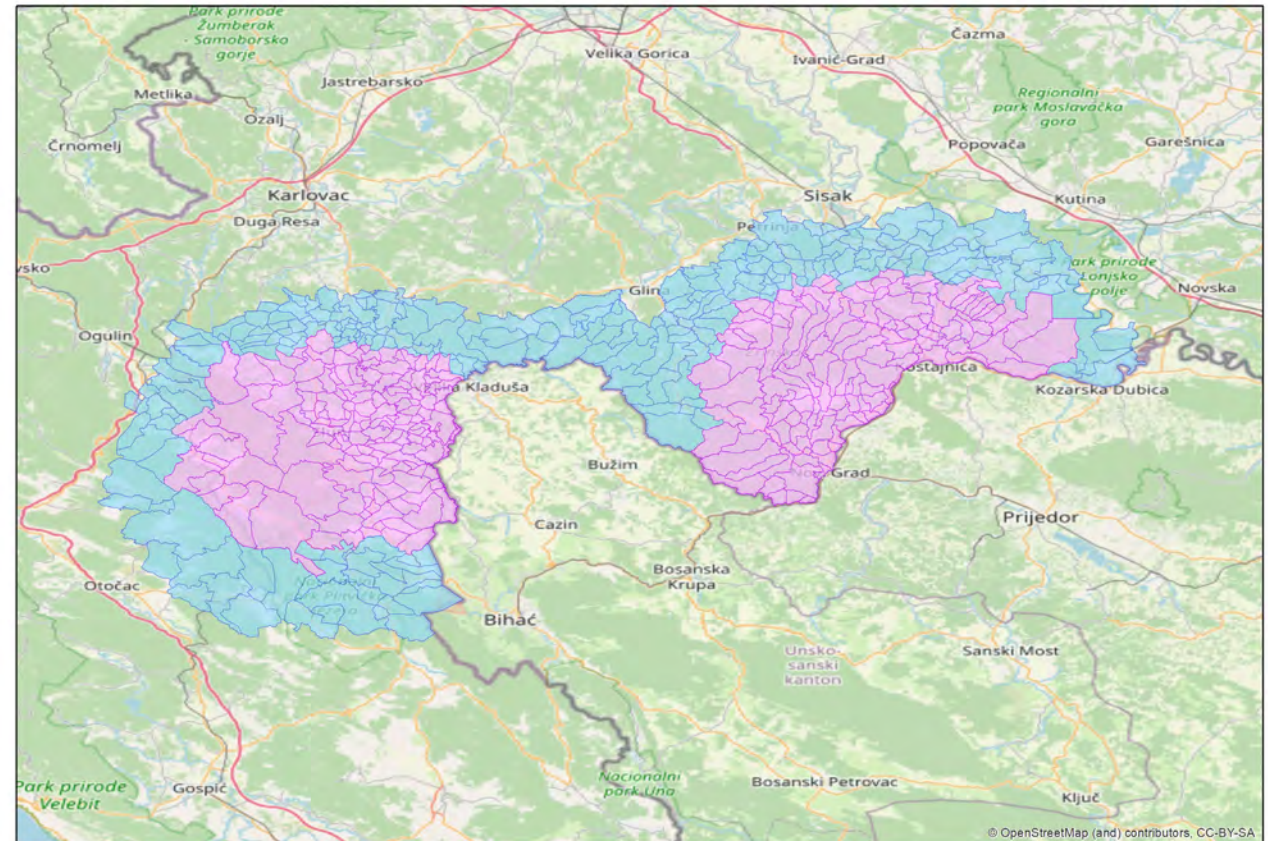

- Reg. 2016/429, DR 2020/687, IR 2023/594, National Animal Health Law (OG 152/22, 154/22)
- Order on control measures to combat ASF in Croatia (OG 117/23, 130/23)
- Guideline for WB sampling and safe disposal

- Census ongoing for Sisak-Moslavina and Karlovac County
- Deadline for emptying of non compliant establishments - November 30
- After the deadline pigs can be kept only on establishments fully compliant with biosecurity measures
- Active search for dead WB
- Increased biosecurity in hunting grounds
- Active and passive surveillance
- Increased hunting – decreasing of WB population up to 10% of biological minimum
