The proposed Decision intends to repeal Commission Decision 2008/698/EC, that lays down additional guarantees in relation to the temporary admission and imports of registered horses from South Africa. The measures laid down in that Decision are replaced by provisions of Regulation (EU) 2016/429, Delegated Regulation (EU) 2020/692 and Implementing Regulation (EU) 2021/404, and therefore are obsolete, and should be repealed.

**B.05** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Annexes II, III and XIII to Implementing Regulation (EU) 2021/404 as regards the lists of third countries, territories or zones thereof authorised for the entry into the Union of consignments of certain ungulates and fresh meat thereof. (MZ)

The proposed Regulation intends to amend Implementing Regulation (EU) 2021/404 by:

1. supplementing Annexes II and III setting out respectively the list of third countries, territories or zones thereof authorized for the entry into the Union of consignments of ungulates, other than equine animals and of ungulates intended for confined establishments, with a specific condition 'ID' for the entry into the Union of such ungulates reflecting derogation provided for in Article 21(5) of Delegated Regulation (EU) 2020/692 introduced by Commission Delegated Regulation (EU) 2023/119, and listing the United Kingdom and its Crown Dependencies of the Isle of Man, Guernsey and Jersey for the entry into the Union of bovine, ovine and caprine animals originating therefrom with such special condition in Annex II and equine animals and of ungulates intended for confined establishments, with a specific condition 'ID' for the entry into the Union of such ungulates reflecting derogation provided for in Article 21(5) of Delegated Regulation (EU) 2020/692 introduced by Commission Delegated Regulation (EU) 2023/119, and listing the United Kingdom and its Crown Dependencies of the Isle of Man, Guernsey and Jersey for the entry into the Union of bovine, ovine and caprine animals originating therefrom with such special condition in Annex II and

2. updating the description of the zones in Botswana in Part 2 of Annex XIII setting out a list of third countries, territories or zones thereof authorised for the entry into the Union of consignments of fresh meat of certain ungulates.
