**APPLICATIONS FOR RENEWAL OF APPROVAL
SUBMITTED UNDER ARTICLE 14 OF REGULATION
(EU) No 1107/2009 AND IN ACCORDANCE WITH
REGULATION (EU) No 844/2012**

This document has been conceived as a working document of the Commission Services. It does not represent the official position of the Commission. It does not intend to produce legally binding effects. Only the European Court of Justice has jurisdiction to give preliminary rulings concerning the validity and interpretation of acts of the institutions of the EU pursuant to Article 267 of the Treaty.

The approval of an active substance can be renewed upon application. Such an application should be submitted no later than three years before the expiry of the approval (Articles 14 and 15 of Regulation (EC) No 1107/2009).

Regulation (EU) No 844/2012 sets out the provisions for the implementation of the renewal procedure for active substances. Articles 1 and 2 of this regulation provide details about the submission of the application and its format and contents.

According to Article 3(6) of Regulation (EU) No 844/2012 the Commission shall publish, for each active substance, the names and the addresses of the applicants whose applications have been submitted by the date provided for in the first subparagraph of Article 1(1) and contain all the elements provided for in Article 2.

Please note that the deadlines for the submission of supplementary dossiers have been advanced by 3 months by Commission Implementing [Regulation \(EU\) 2020/103](#) of 17 January 2020 amending Implementing Regulation (EU) 844/2012 as regards the harmonised classification of active substances. The new rules apply to all renewal procedures of those active substances for which the approval expires on or after 13 May 2023.

Please note that the deadlines for the submission of the renewal application and dossier have been adapted following the adoption of Commission Implementing Regulation (EU) 2020/1740 – this regulation applies to active substances whose approval period ends on or after 27 March 2024. Applications according to those rules must be submitted no later than 3 years before the expiry of the active substance.

Please note that this document only covers active substances falling under Regulation (EU) No 844/2012 (including those originally under Reg. 844/2012 but now under Reg. 2020/1740).

NEW: For active substances for which applications were submitted under Regulation (EU) No 844/2012 but where Regulation EU 2020/1740 now applies, the former applications are obsolete and an application in accordance with Regulation EU 2020/1740 must be submitted 3 years before the expiry of the active substance.
