REPORT OF THE SPS EXPERTS MEETING OF 16 JUNE 2021 TO PREPARE THE WTO SANITARY AND PHYTOSANITARY COMMITTEE OF JULY 2021

The meeting was convened to prepare the upcoming regular meeting of the WTO Committee on Sanitary and Phytosanitary measures (SPS Committee) that will take place virtually on 14 -16 July 2021.

I. GENERAL ISSUES

COM informed the participants about the different events planned in the margins of the next SPS Committee meeting:

- 12-13 July Workshop on risk assessment, risk management and risk communication. DG SANTE and EFSA will give presentations at the different sections of this workshop.
- 14 July STDF and World Bank Webinar "Systems approach in food safety and plant health"
- **14 July** informal meeting, which similarly to the previous time, will discuss the follow-up of the 5th review, procedure to monitor the process of international harmonisation, the proposed SPS declaration for the 12th WTO ministerial conference, COVID issues and upcoming thematic sessions
- **15 July** Information session organized by the United States "Improved SPS Capacity through Distance Learning"

II. SPECIFIC ISSUES

A. Issues of possible interest to third countries.

The issues raised by third countries at the previous SPS Committee meetings were discussed and an update was given by COM on those topics, which were likely to be raised at the next meeting.

B. Issues of interest to the EU

B.1. Possible specific trade concerns (STCs)

The issues raised by the EU at the previous SPS Committee meetings were discussed and an update was given by COM on those topics, which were likely to be raised at the next meeting.

B.2. Monitoring of the use of international standards

COM informed the Member States on cases of third countries trade restrictions not in line with existing international standards (ASF, HPAI) and outlined its planned actions to remedy the situation.

B.3. SPS Market Access Working Group (MAWG)

The next meeting of the SPS MAWG is scheduled for 23 July 2021 in a virtual format. COM outlined the proposed agenda and invited the participants to comment on it.

B.4. <u>SPS market access issues and possible bilateral meetings (in and outside Geneva)</u>

COM informed MS about a number of SPS market access issues and its intention to request bilateral meetings with third countries on the margins of the next SPS Committee meeting and other upcoming meetings with third countries. To prepare the bilateral meetings with third countries, Member States were reminded to provide information on the latest developments on market access issues.
