SUMMARY REPORT

A.01 General information by third countries.

A.02 Information point on import-export issues between the EU and UK (GB).

B.01 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision on the evolution of animal diseases in third countries.

No item raised.

B.02 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation laying down the list of third countries or regions thereof authorised for the entry into the Union of certain animals and products of animal origin intended for human consumption in accordance with Regulation (EU) 2017/625 of the European Parliament and of the Council as regards the application of the prohibition on the use of certain antimicrobial medicinal products.

The Commission submitted the draft Implementing Regulation to the Committee for a formal vote. The proposal establishes the list of third countries, and regions thereof, authorised for the export of certain animals and products derived therefrom intended for human consumption into the European Union, in accordance with the prohibition on the use of certain antimicrobial medicinal products as established in Article 118 of the Regulation on veterinary medicinal products.

Vote taken: Favourable opinion.

B.03 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Annexes V and XIV to Implementing Regulation (EU) 2021/404 as regards the entries for third countries in the lists of third countries, territories or zones thereof authorised for the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds.

No draft was presented for vote. The Commission announced that the next amending act as regards HPAI regionalisation in third countries will include a change in Annex XV to Commission Implementing Regulation (EU) 2021/404, to authorise the entry into the Union of poultry meat products from the HPAI free zone "MD-1" of Moldova, without the requirement to undergo a specific risk-mitigating treatment. The code for treatment for this zone will change from "D" to "A".

C.01 Exchange of views of the Committee on a draft Commission Implementing Regulation amending Implementing Regulation (EU) 2020/2235 as regards model animal health certificates, model official certificates, model animal health/official certificates and private attestation, for the entry into the Union or transit through the Union to a third country of consignments of certain categories of animals and goods intended for human consumption.

The Commission presented the draft Implementing Regulation and invited Member States to provide comments.

C.02 Exchange of views of the Committee on a draft Commission Implementing Regulation amending Implementing Regulation (EU) 2021/403 as regards model animal health certificates and model animal health/official certificates for the entry into the Union of consignments of certain categories of terrestrial animals and germinal products thereof.

The Commission presented the draft Implementing Regulation and invited Member States to provide comments thereto.
