**Section B Draft(s) presented for an opinion**

**B.01** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision on the evolution of animal diseases in third countries.

(B.01\_Emergency disease)

**Procedure:** Examination procedure

**B.02** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending the model certificates for imports into the Union of meat preparations, meat products and treated stomachs, bladders and intestines, as well as fresh meat of domestic solipeds set out in Decisions 2000/572/EC and 2007/777/EC and Regulation (EU) No 206/2010 as regards public health requirements for residues. (AEF/PB/EC)

The draft relates to amendments of the model health certificate for meat preparations, the model health certificate for meat products and treated stomachs, bladders and intestines and the model veterinary certificate for fresh meat, excluding minced meat, of domestic solipeds in order to provide the necessary guarantees that the commodities covered by them, when they are produced from, or contain meat of domestic solipeds, were produced from meat which meets the requirements set out for the imports of fresh meat of domestic solipeds.

**Legal Basis:** Council Directive 2002/99/EC, Articles 9(2)(b) and 9(4); Regulation (EC) No 853/2004, Article 7(2)(a)

**Procedure:** Examination procedure

- B.03** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Annex I to Regulation (EC) No 669/2009 and implementing Regulation (EC) No 882/2004 of the European Parliament and of the Council as regards the increased level of official controls on imports of certain feed and food of non-animal origin. (GB)

The draft Commission Implementing Regulation that will be presented for discussion and opinion is the twenty-first update of the list of feed and food of non-animal origin (fruits and vegetables, herbs and spices etc.) currently subject to an increased level of official controls at the borders in accordance with the provisions of Regulation (EC) No 669/2009. Article 2 of the Regulation requires the Commission to carry out a review of the list in question at least on a quarterly basis.

- B.04** Exchange of views and possible opinion of the Committee on a draft Commission Decision laying down certification rules and a model health certificate for importation into the Union of consignments of live animals and of animal products from New Zealand and repealing Decision 2003/56/EC (NG)

The draft Decision updates certification rules and revises the model health certificate for import of live animals and animal products from New Zealand in order to align to the new rules laid down in the Decision on the amendment of the annexes to the EU-New Zealand Veterinary Agreement (Commission Implementing Decision (EU) 2015/1084 of 18 February 2015). The current Decision 2003/56/EC will thereby be repealed.

- B.06** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Annex I to Regulation (EC) No 798/2008 as regards the entries for Canada and the United States in the list of third countries, territories, zones or compartments from which certain poultry commodities may be imported into or transit through the Union in relation to highly pathogenic avian influenza outbreaks in these countries.
