B.02 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation as regards the listed diseases for which the disease-free status of compartments may be established. (EB)

Article 37 of Regulation (EU) 2016/429 allows Member States to apply to the Commission for the recognition of the disease-free status of compartments. In application of point (b) of Article 37(4) thereof, Article 2 of Commission Implementing Regulation (EU) 2020/690 determines for which listed diseases the disease-free status of compartments may be established. Although Article 37(1) of Regulation (EU) 2016/429 includes category A diseases for compartments keeping terrestrial animals, Annex II to Implementing Regulation (EU) 2020/690 does not include such diseases of terrestrial animals. The proposed Implementing Regulation updates this Annex by adding highly pathogenic avian influenza (HPAI) and infection with Newcastle disease virus (NDV).
