The scope of this Decision is the official recognition of the disease-free status of several Member States and regions thereof as regards tuberculosis and brucellosis in bovine herds, Aujeszky's disease in porcine herds and brucellosis (*B. melitensis*) in ovine and caprine herds, and the approval of the eradication programme carried out in several Member States and regions thereof as regards Aujeszky's disease in porcine herds.

The essential elements for the rules on the identification and registration of certain kept terrestrial animals are already contained in Part IV of Regulation (EU) 2016/429 and complementary details are laid down in Delegated Regulation (EU) 2019/2035. This implementing regulation will provide for technical details for the uniform application of these rules and for the technical specifications of central databases of animal registers, the time limits for recording animal movements in central database, the operational technical rules for the means and methods of identification and the practical application of exemptions from identification and registration requirements.
