The service notes no. 26.462/18.07.2012 INTRANET 4612 and 25774/04.04.2013 INTRANET 4838 were convoked two working groups having the subject the modification and the completion of check-list used for controls during transport. They were prepared and submitted to all the sanitary veterinary and food safety directorates as to be used in controls carried out during transport.

There is also pending approval a service note for increased inspections to verify compliance with the protection of animals during transport, between 1 July to 30 September 2013. Inspections will be conducted in the following objectives: place of departure, place of destination, in the traffic, at long distance carriers, at short distance carriers and control points. This note contains a .refresh of the notification procedure of the romanian contact point, where there are identified violations of the legislation on the protection of animals during transport made by foreign carriers / drivers in national territory in accordance with Council Regulation no.1/2005, art.26.
