It proposes recognising the residues monitoring plans for Andorra (honey), Morocco (poultry), and for Armenia, Kenya and the Republic of the Union of Myanmar (aquaculture). The proposal also clarifies the territorial coverage of the residue monitoring plan for Israel.
