
• OBJECTIVES, SCOPE AND ACTIVITIES

HaDEA management of grants

- Assessment by HaDEA will be based on the published call document
 - Invitation to submit proposals' submitted to nominated authorities on 12/12/2022
 - This will include an assessment of the technical priorities identified in the EFSA assessment of January 2023



Risks:

- Open-ended technical specifications can make more challenging the assessment
- Too broad list of activities can dilute the funds available
- Many countries expressed interest to HaDEA already



Considerations for the next steps:

- Consortia are encouraged
- Prioritise activities in line with the 2022 WP (i.e. emerging and reemerging pathogens; implement innovative and reinforced surveillance activities)
- Avoid open-ended technical specifications
- Avoid financing of activities already regulated



Provisional timeline of CP-g-22-04.01 next milestones:

- EFSA identification of surveillance modalities with support of ECDC & MS
 - HaDEA opened call for proposals

Deadline for MS to Submit to HaDEA proposals

1 Dec 2023

15 Dec

• Signature of grants and start of 3 y surveillance activity
