B.02 Exchange of views and possible opinion of the Committee on a draft Commission Regulation amending the model certificates for imports into the Union of meat preparations, meat products and treated stomachs, bladders and intestines, as well as fresh meat of domestic solipeds set out in Decisions 2000/572/EC and 2007/777/EC

The draft relates to amendments of the model health certificate for meat preparations, the model health certificate for meat products and treated stomachs, bladders and intestines and the model veterinary certificate for fresh meat, excluding minced meat, of domestic solipeds in order to provide the necessary guarantees that the commodities covered by them, when they are produced from, or contain meat of domestic solipeds, were produced from meat which meets the requirements set out for the imports of fresh meat of domestic solipeds.

Routine update of the list of CN codes of animals and products to be subject to controls at border inspection posts when introduced into the EU from non-EU countries. The update takes into consideration changes made to the Combined Nomenclature of the Common Customs Tariff, clarifications requested by Member States veterinary and customs authorities, changes in the animal by-product legislation and alignment with the CN codes in TRACES.

C.01 Exchange of views of the Committee on a draft Commission Implementing Regulation amending Annex II to Regulation (EU) No 206/2010 as regards the list of third countries, territories or parts thereof from which the introduction into the Union of fresh meat is authorised. (HH/PB)

This draft will authorise certain territories of Argentina and Brazil for the introduction of fresh meat of bovine and ovine animals into the EU. Those territories are already recognised by the OIE as foot and mouth disease free. Furthermore, the regionalisation of Argentina will be simplified.

C.02 Exchange of views of the Committee on a draft Commission Implementing Decision amending Annex II to Decision 2007/777/EC as regards the list of third countries or parts thereof from which the introduction of meat products and treated stomachs, bladders and intestines into the Union is authorised. (HH/PB)

With this drafts the regionalisation of Argentina and Brazil which is applied in Decision 2007/777/EC for import of meat products from meat of domestic bovine animals, will be aligned with the regionalisation applied in Regulation (EU) 206/2010 for import of fresh meat of domestic bovine animals. Furthermore a new part of Brazil will be authorised for the introduction into the Union of meat products from meat of domestic bovine animals subject to the treatment "B".

C.03 Exchange of views of the Committee on a draft Commission Implementing Regulation amending Commission Implementing Regulation (EU) 2015/943 of 18 June 2015 on emergency measures suspending imports of dried beans from Nigeria. (AS)

The Commission Regulation 2015/943 of 18 June 2015 set a ban on dried beans (under CN code 0713 39 00) imported Nigeria until 30 June 2016.

During the ban period, consignments of dried beans still reached the EU under other CN codes (Member States to inform the Commission).

Also, by 15 March 2015, the Nigerian authorities still have not provided guarantees that they have put in place an adequate official control system to ensure that the products concerned are in line with the standards laid down in EU legislation.

The scope of the CN code is extended.
