Outcome of Step 1:

Six business operators sent a reply to the step 1 of the call for scientific and technical data on the permitted food additives oxidised starch (E 1404), monostarch phosphate (E 1410), distarch phosphate (E 1412), phosphated distarch phosphate (E 1413), acetylated distarch phosphate (E 1414), acetylated starch (E 1420), acetylated distarch adipate (E 1422), hydroxypropyl starch (E 1440), hydroxypropyl distarch phosphate (E 1442), acetylated oxidised starch (E 1451) and starch aluminium octenyl succinate (E 1452).

Four business operators explicitly expressed their interest in submitting the requested data regarding the specifications (Section 1.1 of the call for data).

Two business operators explicitly expressed their interest in submitting data on uses/use levels (Sections 1.2 and 1.3 of the call for data).

One business operator expressed its interest in submitting toxicological data required for oxidised starch (E 1404), monostarch phosphate (E 1410), distarch phosphate (E 1412), phosphated distarch phosphate (E 1413), acetylated distarch phosphate (E 1414), acetylated starch (E 1420), acetylated distarch adipate (E 1422) and acetylated oxidised starch (E 1451) for the uses in food category 13.1.5.2 'Dietary foods for babies and young children for special medical purposes as defined in Directive 1999/21/EC' (Section 2 of the call for data).
