In order to create a disincentive for catching juvenile fish for fish conservation purposes, Regulation (EU) No 1380/2013 restricts the use of catches of fish below the minimum conservation reference size ("undersized fish") for purposes other than direct human consumption. The administrative decision to exclude undersized fish from the human consumption chain is based on Union fishery legislation and does not address an animal or public health risk. Storage of undersized fish together with other fish that may be placed on the market as fit for human consumption should therefore be authorised
