For this reason, in the same Regulation (EU) 2017/270, an additional request for further monitoring data of tropospheric concentrations of sulfuryl fluoride, on a regular basis every fifth year, is included in order to ensure that the steady state is fully proven. This last request is to be seen as falling under the provisions of Article 6(i) of Regulation (EC) No 1107/2009 which provides for
