

NOTIFICATION OF REDUCED PLANT HEALTH CHECKS FOR CERTAIN PRODUCTS

Period: 01.01.2023 - 31.12. 2023

Commission Implementing Regulation (EU) No. 2022/2389¹ specifies the detailed conditions for the evidence required and the criteria for the type and level of the reduction of the identity checks and physical checks on consignments of certain plants, plant products or other objects (goods) referred to in Article 47(1)(c) of Regulation (EU) 2017/625.

Following the application of the criteria laid down in Regulation 2022/2389, through a methodology developed in a Commission Working Group on 19 October 2004, and after consultation with the Plant Health Standing Committee on 26 October 2022, certain goods from specified countries of origin, shall be subject to at least a minimum level of identity and physical checks. The list of goods subject to such reduced inspections, their countries of origin and the minimum percentage of consignments to be inspected, is officially available in Annex I to Regulation 2022/2389², and annexed to this notification for information purposes. The reduced level of inspection shall apply from the date specified in the table annexed herewith and shall be applied until revised by the Commission.
