A. Technical information

By submitting this programme, the Member State (MS) attests that the relevant provisions of the EU legislation will be implemented during its entire period of approval, in particular:

- Regulation (EC) No 2160/2003 on the control of *Salmonella* and other specified food-borne zoonotic agents,
- Regulation (EU) No 200/2010 implementing Regulation (EC) No 2160/2003 of the European Parliament and of the Council as regards a Union target for the reduction of the prevalence of *Salmonella* serotypes in adult breeding flocks of *Gallus gallus*,
- Regulation (EC) No 1177/2006 implementing Regulation (EC) No 2160/2003 as regards requirements for the use of specific control methods in the framework of the national programmes for the control of *Salmonella* in poultry.

As a consequence, the following measures will be implemented during the whole period of the programme:

1. The **aim of the programme** is to implement all relevant measures in order to reduce to 1% or less the maximum percentage of adult breeding flocks of *Gallus gallus* remaining positive for the target *Salmonella* serovars: *Salmonella* Enteritidis (SE), Typhimurium (ST)(including the antigenic formula 1,4,[5],12:i:-), Hadar (SH), Infantis (SI) and Virchow (SV).

For a MS with less than 100 adult breeding flocks of *Galus gallus* the target is to have no more than one such flock remaining positive for the relevant *Salmonella* serovars per year.

Los servicios veterinarios oficiales de las comunidades autónomas (CCAA) ordenan los sacrificios obligatorios y son los encargados de llevar a cabo las compensaciones por sacrificio. Las CCAA son las encargadas de pagarlos.

Las vacunas son compradas por los FBO, o bien directamente, o bien a través de Agrupaciones de Defensa Sanitaria (ADS), que son asociaciones de ganaderos, siendo mayoritaria (prácticamente el 100% de los casos) esta segunda opción.

La vacunación es responsabilidad del ganadero, que puede ser quien la aplique directamente, o que lo haga el veterinario privado de la explotación, en este caso, el ganadero sería el encargado de pagarle.

La administración paga las dosis de vacunas al ganadero y en la mayoría de los casos, prácticamente en el 100% de los casos, lo hace a través de las asociaciones de ganaderos (ADS).

La limpieza y desinfección de las instalaciones se realiza siempre después de vaciar las naves.

Antes de repoblar nuevamente las naves, es obligatorio verificar la limpieza y desinfección, tomando muestra ambientales.

Estas actividades corren a cargo del FBO, y es el quien las paga.
