





The Autostrade Company defined priorities and the timeline of activities




2° line of fences


Cronology of the events

Local Health Unit Rome 1 – Rome Municipality – South border of Insugherata Park - LONG 41,946479 - LAT 12,422943 (WGS84)

- 28 April 2022: reporting the presence of a young wild boar, euthanized die to neurological synthoms
- 29 April 2022: Sample from spleen sent to the Istituto
 Zooprofilattico del Lazio e Toscana
- 04 May 2022: positivity by IZSLT
- 05 May 2022: Confirmation by CEREP Genotype II ASFV
- 05 May 2022: ASF Expert group meeting with hypothesis of the Infected Zone
- 06 May 2022: Central Crisis Unit meeting

How ASF has arrived in Rome?

Based on evidence, the most accredited hypothesis is the human factor: garbage management and passages from parks to the city, feeding by people (animal activists)















Reporting of presence of wild boars in Rome






Infected Zone and Attention Zone






Infected Zone and Attention Zone

Infected Zone

- Definition of Provisional Infected
 Zone in accordance to Commission
 Implementing Decision concerning
 certain interim emergency measures
 relating to African swine fever in Italy
- Enhancement of passive surveillance and active search of carcasses
- Management and disposal of carcasses
- Virological test in wb and domestic pigs found dead (art. 9, paragraph 1, Delegated Regulation (EU) 2020/689
- Signals that aware people about risks linked to the presence of the virus have to be applied in the Infected Zone, included the grazing ban on feral pigs

Infected Zone

- Regulation of outdoor activities
- Identification of establishments which holds pigs or boars, even temporarily, not already registered in BDN
- Identify «pet pigs» not already registered and inform owners about biosecurity measures to be applied
- Prohibition of movement of domestic pigs and wild boars caught in protected areas and other wildlife establishments other than that aimed at slaughtering;
- Enhancement of checks on pigs movements
- pig holdings census
- Depopulation of backyard and commercial farms

Attention zone

- Actve search of carcasses
- In Regional Parks closing of passages to infected zone
- pig holdings census
- Hunting prohibition in all areas inside the GRA






