# Third outbreak HPAI H5N8 in backyard poultry

- Vukovar srijem county
- Location village
   Mlaka Antinska
- Infected farm HR 90019423
- Mixed species

   (hens, ducks,
   geese, pigeons)



### Outbreak Mlaka Antinska

- High mortality (63 hens) reported to the veterinarian on Feb, 8
- 5 dead hens were sent to the lab the same day
- Standard sample set (20 swabs and blood samples) were taken from ducks and geese
- Initial confirmation on Feb 9 H5N8
- Farm located at the waterside of the river
   Vuka
- Large number of wild birds located by the same river
- Direct contact between domestic and wild birds
- Stamping out on Feb 10



## Measures applied according to the Directive 2005/94


- Movements restrictions
- Zoning 3 and 10 km: protection and surveillance zone is established
- Stamping out of birds on the infected farms
- Epidemiological investigation
- 5 contact farms have been identified / 4 infected
- All infected farms (5) and contact farm (1) stamped out (475 animals)
- Census and visit by authorised vet of all the holdings have been performed (Feb 11-12)
- Cleaning and disinfection on the farms
- 198 holdings with poultry (183 registered holdings) within 3 km protection zone: Antin, Mlaka Antinska and Tordinci
  - Gallus gallus (laying and breeding) 4202
  - Gallus gallus broilers 129
  - Ducks 276
  - Geese 76
  - Turkeys 48
  - Pigeons 83
  - Other (guinea fowl, birds) 22
- No commercial farms in the zones
- Without suspicion on other holdings

- Mute swan Cerna, Vukovar-srijem county
- Mute swan Bijelo Brdo, Osijek-baranja county
- Mute swan Mužilovčica, Sisak-moslavina county
- Mute swan, great cormorant lake Jarun, City of Zagreb
- Mute swan lake Soderica Koprivnica-krizevci county
- Great cormorant Virovitica-podravina county
- Mute swan lake Bundek, City of Zagreb
- Mute swan river Korana, Karlovac county
- Mute swan Gabajeva Greda Koprivnica-krizevci county
- Mute swan Lipovljani Sisak-moslavina county
- One location H5N5 Mute swan Crkveni Bok, Sisak-moslavina county

### HPAI H5N8 and H5N5 SUMMARY WILD BIRDS (11) AND POULTRY (3)



## Ongoing measures (Order OG 5/17, 13/17)

- Prohibition on the whole territory of:
  - outdoor keeping of poultry, feathered game and captive birds
  - keeping of domestic ducks and geese species together with other poultry
  - use of outdoor water reservoirs and feed
  - gathering of poultry and other captive birds at markets, shows, exhibitions, cultural events and other events
- Mandatory minimal biosecurity measures for all holdings keeping poultry
- Hunting of feathered game banned in the 20 km zones around location where HPAI is confirmed

# Measures envisaged for the next period

- Stricter measures only in risk areas, not for the whole teritory / in line with COMMISSION IMPLEMENTING DECISION (EU) 2017/263
- Increased surveillance

 Risk areas in the vicinity of watersides and close to wild birds wintering places and wetlands (e.g. nature

parks Lonjsko polje and Kopacki rit)
