Control in sanitary issues and veterinary affairs is shared between the Ministry of Agriculture and Forestry Biosecurity Authority and the New Zealand Food Safety Authority. In this respect the following applies:

- in terms of exports of live animals and germplasm to the Community the Biosecurity Authority is responsible for certification (official assurances) attesting to the agreed veterinary standards and requirements;
- in terms of exports of all other animal products to the Community the New Zealand Food Safety Authority is responsible for certification (official assurances) attesting to the agreed veterinary standards and requirements;
- in terms of imports the Ministry of Agriculture and Forestry Biosecurity Authority is responsible for animal health quarantine (zoo-sanitary) issues while the New Zealand Food Safety Authority is responsible for food safety (sanitary) and related standards and requirements.'
