The purpose of the draft is to adapt the models of certificate and declaration for dogs, cats and ferrets from third countries to increase the maximum required time between the movement of the animal and the movement of the owner or authorised person.

Decision allows EU Member States to import L-Cysteine, glucosamine, chitosan and chondroitin from China.

The reasons which led to the adoption of the Commission Decision 2002/994/EC are not applicable to those highly refined products as they do not pose problems for the presence of chloramphenicol and nitrofurantoin.
