- B.06** Exchange of views and possible technical agreement of the Committee on a draft Commission Implementing Regulation establishing the list of animals and products subject to official controls at border control posts, including their codes from the Common Nomenclature. (CJ)

As the new import requirements for composite products only will become applicable on 21 April 2021, the current list of such products in Commission Decision 2007/275/EC shall continue to apply until then. Hence, the list established in this draft Regulation does not cover composite products. The draft Regulation will be presented for a technical vote.

B.07 Exchange of views and possible technical agreement of the Committee on a draft Commission Implementing Regulation on the procedures for a coordinated performance of intensified controls at border control posts. (CJ)

This Draft Implementing Regulation lays down the procedures for a coordinated performance by the competent authorities of intensified controls on products of animal origin, germinal products and animal by-products at border control posts. The draft Regulation will be presented for a technical vote.

Procedure: Examination procedure
