EU has sought specific information on status of *Xylella fastidiosa* (gram negative bacterium) in India and to submit the same by 31.12.2020. The status of *Xylella fastidiosa* in India was conveyed to the Delegation of the European Union to India on 31.12.2020 (Copy enclosed).

- 2. In this regard, it is again stated that *Xylella fastidiosa* is not reported in India and it is a quarantine pest of concern to India as per Plant Quarantine (Regulation of Import into India) Order, 2003. CABICPC (https://www.cabi.org/cpc/datasheet/57195#todistributionDatabaseTable) and EPPO website (https://gd.eppo.int/taxon/XYLEFA/distribution/IN) also reports as "absent, unconfirmed presence record' under distribution table.
- 3. In view of this, India to be considered as "Xylella fastidiosa is known not to be present in India on the basis of inspection, sampling and molecular testing carried out by the competent authority, using a test listed in Annex IV of Regulation (EU) 2020/1201, and in accordance with relevant ISPM measures." However, NPPO-India will certify at the time of export of planting materials as per the EU regulations specified under Article-28 and Article-29 of 2020/1201.
